

## **REPORT IN C/W ONGOING SRER, 2014 AND SVEEP**

Hooghly sadar Sub Division comprises of five ACs namely, 190 Chinsurah, 191 Balagarh (SC), 192 Pandua, 193 Saptagram and 197 Dhaniakhali. The draft roll has been duly published at all the ACs on 2<sup>nd</sup> September, 2013 and all BLOs and DOs as well as the supervisory officers have been properly trained in connection with the programme.

### **Special Initiatives:**

#### **1. Roll Reading at Village level:**

The part wise Roll has been read out at each village level by the respective BLOs on 5<sup>th</sup> of Sept, and informations regarding dead and shifted voters have been duly received from the local persons. A similar exercise will be done on 12.09.13 to ensure cleansing of Roll at all booths.



#### **2. Electors' Information Slip:**

The electors' Information Slip in prescribed format have been properly distributed to the electors by the respective BLOs. This has certainly generated a level of awareness among the electors and inspired confidence on the Electoral system as also on the Election machinery at the district level.



### 3. Special Campaign:

The Special Campaign date has been observed on 8<sup>th</sup> of September, 2013 as per the guideline of ECI. Election Officers were available at all designated locations from 10 AM till 5PM on that date and received applications in prescribed forms. ### 3. BLO-BLA meeting:

### 4. Information to Political Parties:

The Political Parties have been properly briefed by the District Election Officer and DM, Hooghly on the latest guidelines and recent activities regarding roll revision on 06.09.13 in presence of the Roll Observer and Divisional Commissioner, Burdwan Division. The list of claims and objections in Form 6 /7 are being collected and uploaded in the CEO's website for information of the public at large. The same will also be shared with the political parties in due time as per the instructions of ECI by the respective EROs.

**SVEEP:**

Series of events have been contemplated to generate awareness among the electors and with particular emphasis on 18-19 age group persons.

- Sit and draw competition at schools with participation by students of this age group have been successfully organized at different schools and the winning candidates will be awarded with a token prize on the National Voters day.
- Human Chain by SHG members have also been organized at each Assembly Constituency with an intention to popularize the revision process and inspire the general youth in applying for electoral registration.
- The Kite festival will also be held on 17<sup>th</sup> of Sept, 2013 wherein Kites, embossed with ECI logo will be flown at local levels by 18-19 age group electors.
