The wage rate for unskilled worker has been revised and fixed at Rs. 130.00 with effect from 01.01.2011 vide MoRD's no. J-11011/1/2009-MGNREGA(Pt) dt. 14.01.2011 from the Chief Economic Advisor, MoRD, GoI. A copy of the same is enclosed. The wage rate for the semi-skilled & skilled workers will accordingly be Rs. 195.00 and Rs. 260.00 respectively. This new revised rates of wages are to be applied in case of labourers who have worked on or after 01.01.2011 untill further order.

S.O. (E) – In exercise of the powers conferred by sub-section (1) of section 6 of the Mahatma Gandhi National Rural Employment Guarantee Act, 2005 (42 of 2005), and in supersession of the notification of the Government of India in the Ministry of Rural Development number S.O. 1(E), dated the 1st January, 2009, except as respects things done or omitted to be done before such supersession, the Central Government hereby specifies the wage rate payable to the unskilled manual workers under column (3) in respect of the State or the Union Territory mentioned in column (2) of the Schedule given below, working on various Schemes under the said Act, with effect from the 1st day of January, 2011, namely:-
