Being authorized by the learned Chairman, DLSA, Hooghly vide order no. 744 dated 13.09.2017 it is hereby notified as follows:-

- District Legal Services Authority, Hooghly in compliance of the direction of National Legal Services Authority as well as State Legal Services Authority is intending to increase the number of empanelled Para Legal Volunteers from 24 to 100. Thus, applications are invited from adult individuals (male, female and third gender) with a mindset to serve the society by associating himself/herself as Para Legal Volunteers of District Legal Services Authority, Hooghly.

- **Who can apply?-**

Any individual who is a permanent resident of Hooghly district and is literate (preferably matriculation) with the capacity for over all comprehension and who do not look up to the income they derive from the service as Para Legal Volunteers but he should have a mindset to assist the needy in the society coupled with the compassion, concern and empathy for the weaker section of the society.

- **Groups from where Para Legal Volunteers can be selected?-**

1. Teachers (including retired teachers)
2. Retired Government Servants and senior citizens
3. MSW Students and Teachers
4. Anganwari Workers
5. Doctors/ Physicians
6. Students and Law Students (till they enrolled as Lawyers)
7. Persons from non-political service oriented NGOs and Clubs
8. House wives, women from self-help group
9. Any other person having no political affiliation and having the mindset to serve the society.

- **Honorarium -**

Every applicant must keep in mind that this is not a job opportunity of any kind and earning money is not the purpose of association as Para Legal Volunteers. There is no question of payment of fixed monthly honorarium. However, honorarium may be allowed as may be permissible after considering the number

of days employed and performance and contribution of the Para Legal Volunteers from time to time.

- **Duties of Para Legal Volunteers-**

The Para Legal Volunteers are expected to act as intermediaries bridging the gap between the common people and the Legal Services Institution so that the people can get justice. The Para Legal Volunteers shall educate people specially those who belong to the weaker section of the society to enable them to be aware of their rights to live with human dignity and to enjoy all the legal rights and discharge obligation as per laws. The Para Legal Volunteers shall assist DLSA for organizing legal awareness camps in their area of operation.

The duties mentioned above are just illustrative in nature and not exhaustive.

- **Date and Place for submission of application-**

Application should reach to the Office of District Legal Services Authority, Hooghly at ADR Centre, Serampore, 6 T.C. Goswami Street, Pin- 712201 by post or by any other mode in the prescribed format by 17th November, 2017.

- The selection of Para Legal Volunteers shall be made by Selection/Recruitment Committee of DLSA, Hooghly and the candidates shall be selected through an interview/personality test. If it appears to the Authority that the number of applications is huge then a preliminary screening of the applications may be done to short list the number of candidates. The basis of screening and elimination will be decided by the Selection Committee after getting the applications. The Selection Committee shall try to empanel Para Legal Volunteers from each and every Block of Hooghly District.
- Date of interview will be intimated later on through our Website- www.dlsahooghly.org or over the phone by 30th November, 2017.
