Eligible Criteria are as follows :-

- Income Criteria -- Family annual income not more than 60,920/-
- Candidate must belong to SC or ST.
- Qualifying Marks :- Candidates who have secured pass mark in each subject in the last year annual examination and having at least 75% attendance in the last academic session may only be considered eligible for such grant.
- Candidates for Class IX & X who are receiving grant under the scheme "Special Merit Scholarship for the classes IX to XII" will not come under the purview of this scheme.
- Usually selection will be made in order of merit of the applicants against the available district quota for each classes / category in the last annual examination.
