ECI/PN/23/2019 Dt. 10th March, 2019 by the Election Commission of India, New Delhi</p> <p>AND</p> <p>Whereas, there is apprehension of breach of peace, disturbance of public tranquillity due to carrying / movement of Fire Arms resulting in Law and Order problem during Election process.</p> <p>AND</p> <p>Whereas, as per Election commission of India vide memo. no. 464/INST/2009/EPS dated 01.09.2009 in order to conduct the General Election peacefully carrying / movement of all Fire Arms shall be prohibited</p> <p>AND</p> <p>Whereas, in order to conduct the General Elections to the Loksabha 2019 peacefully in the District Hooghly it is expedient to impose restriction on carrying / movement of all Fire Arms</p> <p>Now therefore in exercise of the power conferred upon me u/s. 144(2) of the Code of Criminal Procedure 1973 I, Jagdish Prasad Meena, IAS, District Magistrate, Hooghly do hereby proclaim and invoke the provision of Section 144 in the areas of Hooghly Rural District.</p> <p>I do hereby prohibit the carrying / movement of all Fire Arms within the areas of Hooghly Rural District till the completion of the Election Process.</p> <p>Police is empowered to take necessary action against a person or group of persons if they are found violating this order.</p> <p>This order does not apply to the officers / personnel engaged in Law and Order duty.</p> <p>This order will take immediate effect and shall remain in force till 27.05.2019.</p> <p>Let this order be served upon all concerned.</p> <p>Signed under my hand and seal this 11th day of March of 2019</p> <p> District Magistrate, & District Election Officer, Hooghly</p>
