The extension portion from Jirat High School math to Jirat Smriti Mandir 3no. Primary School is about 2 km approx which will be benefited for the local peoples.	Extension from Jirat High School math to Jirat Smriti Mandir 3no. Primary School is allowed.

C- Transfer of Permit :-

4	Sri Jayanta Maiti has prayed for transfer of permit vide no. 1034/2002 in respect of vehicle no. WB15C1487 (Bus) plying in the route no. 16/20 (Arambagh to Tarakeswar) to Md. Tafazzul Hossain.	The permit vide no. PSP-21025 in respect of vehicle no. WB15A5712 was issued in the name of Sri Jayanta Maiti, The respective bus is found registered in the name of Soumen Maiti. Now, the permit may be transferred at first in the name of Soumen Maiti and finally in the name of Md. Tafazzul Hossain. The bus will ply in the same route.	The case of both transfer of ownership of vehicle & permit only is allowed in the same route. It is also unanimously decided that in case of transfer of permit other than legal hairs, Permit holder will not be allowed to apply for any permit for next two years. Transfer of ownership of vehicle will be allowed only after granting permission for the respective permit.
5	Sri Mohan Shaw has prayed for transfer of permit vide no. PSP-39778 in respect of vehicle no. WB19E3574 (Bus) plying in the route no. 225 (Uttarpara to Bhagabatipur) to Sri Subarna Patra.	It has been found from the prayer of the applicant that he wants to Transfer of Permit and joint petition received from both seller & purchaser. The Bus will ply on the same route.	The case of both transfer of ownership of vehicle & permit only is allowed in the same route. It is also unanimously decided that in case of transfer of permit other than legal hairs, Permit holder will not be allowed to apply for any permit for next two years. Transfer of ownership of vehicle will be allowed only after granting permission for the respective permit.
