In pursuance of Memo no. 3265-WT/3M-50/2013 dated 03.09.2013 of Transport Department, Govt. of West Bengal & in terms of resolution dated 26.08.2013 of RTA, Hooghly, it is hereby notified that RTA, Hooghly is going to issue 100 (one hundred) non-AC & 100 (one hundred) A.C Metered Taxi Permits as Contract Carriage Applications are hereby invited from the interested persons in the following manners.

Applications in Form No. II accompanied with the following papers/documents:-

- (i) Application Fees for Rs. 500/- (Rupees five hundred).
- (ii) Residential Address Proof (Self attested) of KMA within the District of Hooghly.
- (iii) Proof of place of Business, if the applicant is a resident out side of KMA in Hooghly District, with rent agreement as per Rule 2(1) of WBMV Rules, 1989.
- (iv) One self attested photograph.
- (v) Financial capability. Bank Pass Book having current balance of at least 15% margin money of the vehicle cost.
- (vi) Affidavit according to Govt. Notification No. 2961 (4)-WT/3M-50/2013 dated 05.08.2013 & 3265-WT/3M-50/2013 dated 03.09.2013.

*** Period of submission of application: from 01.10.2013 to 08.11.2013 from 11.00 am to 04.00pm (except holidays)

OTHER CONDITIONS FOR NON A.C. TAXI PERMITS:-

- (i) Only 1 (one) application will be entertained from one (1) individual at a time & the applicant has to submit the application only by himself.
- (ii) If it is found that one (1) applicant has submitted more than 1 (one) application, then only first one (1) valid application will be taken into consideration for Metered Taxi Permit & others will be rejected.
- (iii) Incomplete application will be rejected without further reference. This permit will not be transferable in future without permission from the RTA, Hooghly.
- (iv) Priority will be given to the Ex-serviceman, Co-operative Societies as per M.V. Act'1988 u/s 74/3 (b).
- (v) All terms & conditions as laid down in Transport Department's G.O no. 3265-WT/3M-50/2013 dated 03.09.2013 of Transport Department to be strictly complied with.
- (vi) All application must be accompanied with a signed affidavit in specific format which will be supplied from this end.

OTHER CONDITIONS FOR A.C. TAXI PERMITS:-

- (i) Individual or organized sector as per section 74/3 (b) of the M.V. Act' 1988 is eligible for application.
- (ii) Only 1 (one) application will be entertained from one (1) individual or Ex-serviceman at a time & the applicant has to submit the application only by himself. If it is found that one (1) applicant has submitted more than one (1) application, then only first one (1) valid application will be taken into consideration for Metered Taxi Permit & others will be rejected.
- (iii) Maximum 10 (ten) applicants for A.C. Metered Taxi Permits can be submitted by organized sectors (must be registered in KMA, Hooghly and must have proper business address in KMA, Hooghly if from non-KMA, Hooghly) like Registered Co-operative Society, Tourism Development Corporation, Registered Tour Operators etc. The authorized representative of these sectors may submit applications for Meter Taxi. This permit will not be transferable in future without permission from the RTA, Hooghly.
- (iv) Priority will be given to the Ex-serviceman, Registered Co-operative Societies Tourism Development Corporation as per M.V. Act' 1988 u/s 74/3 (b).
- (v) All terms and conditions as laid down in Transport Department's Memo No. 3265-WT/3M-50/2013 dated 03.09.2013 to be strictly complied with.
- (vi) All application must be accompanied with a signed affidavit in specific format which will be supplied from this end.

- (ii) That I am applying for the above mentioned permit vide Form no. II along with prescribed fee, supporting documents viz Address Proof (Photo Copy) , photograph, Bank Pass Book (photo Copy) etc.
- (iii) That I shall abide by all the terms and conditions as laid down in the aforesaid G.O. if an Offer letter / Permit is issued in my favour. That means, I shall produce a new BS-IV complaint A.C. Vehicle which will be sedan type having 4+1 Seating capacity with minimum engine capacity 1150 C.C. and its colour will be blue & white combination bearing "No-Refusal" logo & fitted with GPS /GPPRS based navigational & location indicating devices & with Govt. approval meter including thermal printer which will also be calibrated as per current approved fare rates. 25% extra fare will be added to the fare shown in the meter for using A.C. If A.C. is kept in off mode as per choice of the passengers, no additional fare will be charged. Moreover, I shall arrange to keep two news papers (one Bengali & one English) regularly at my cab in addition to music system and other applications.
- (iv) That I shall not suspend the vehicle due to any call of strike, Bandh, Hartal etc. on any day and further to the effect that there shall be no refusal to accept passengers on hire by the driver while driving the vehicle at any place & at any time of the day or night.

I also declare that if any of the above conditions is violated then appropriate actions may be imposed upon me as per motor Vehicles Act & Rule and even upto permit may be treated as cancelled.
