O R D E R

WHEREAS, the General Elections to the Lok Sabha 2019 in Chandannagar Police Commissionerate has been declared vide Press Release No. ECI/PN/23/2019 dtd. 10.03.2019 by the Election Commission of India.

AND

WHEREAS, there is apprehension of breach of peace, disturbance of public tranquillity due to carrying/movement of Fire Arms resulting in Law & Order problems during the Election process.

AND


WHEREAS, as per Election Commission of India vide Memo No. 464/INST/2009/EPS dtd. 01.09.2009 in the order to conduct the General Elections to the Lok Sabha 2019 in Chandannagar Police Commissionerate peacefully, carrying/movement of all Fire Arms shall be prohibited.

AND

WHEREAS, in order to conduct the General Election to the Lok Sabha 2019 peacefully in Chandannagar Police Commissionerate, it is expedient to impose restriction on carrying/movement of all Fire Arms.

I, Akhilesh Kumar Chaturvedi, I.P.S. Commissioner of Police, Chandannagar Police Commissionerate in exercise of power conferred upon me u/s 144 of Criminal Procedure Code 1973, do hereby prohibit carrying/movement of all Fire Arms within the entire Chandannagar Police Commissionerate till the completion of Election process.


