1	W.P. No. 26249 (W) of 2015 and CPAN 473 of 2016 of Raosanara Begam has been received from Ld. Advocate Mr. Biswapriya Samanta with direction of the Hon'ble High Court to consider the application after giving an opportunity of hearing to the petitioner.	The petitioner applied for new Trekker permit on the route from Fidler Road to Khadinamore (05/TR/ST) and rejected in the following grounds: "As per statistics, existing nos. of public transport is more than sufficient in proportion to the passengers' pressure & traffic congestion. Traffic problem, lack of business opportunity, unhealthy competition and violation of law & order are seriously apprehended if new permits are issued at present. Hence not recommended". Now, it has been observed that that Tarakeswar-Chinsurah Bus Syndicate, Haripal-Chinsurah Bus Syndicate filed objection for allowing any new permit for the route in question.	The petitioner is heard and considered. MVI(NT)s are directed to place survey report of that route within next RTA meeting to be held on 23.06.2016 and the Secretary, RTA is directed to call for another hearing on the next RTA Board meeting and communicate the decision to all concerned including the Hon'ble High Court.

Advocate Biswapriya Samanta with direction of the Hon'ble High Court to communicate the decision of hearing of RTA, Hooghly dated 28.01.2016 to the petitioner.	The petitioner applied for new Trekker permit on the route no. 27/TR/ST (Jangipara to Serampore) and the Hon'ble Justice Mr. Samapti Chatterjee has directed to communicate the decision of hearing of RTA, Hooghly dated 28.01.2016 to the petitioner.	The application is re-considered and the Secretary, RTA is directed to communicate the said decision to all concerned.
3	W.P. No. 10239 (W) of 2015 of Amitava Dutta & Ors., has been received from Ld. Advocate Mr. Baidurya Ghosal with direction of the Hon'ble High Court to reconsider the application after giving an opportunity of hearing to the petitioner.	The petitioner are the permit holders of Mini Bus Route 225 (Bhagabatipur to Uttarpara Stn.) and they complained against illegal plying of Tata Magic/Maxicab of route no. 27/TM/CC (Dharsa Petrol Pump to Chandital BDO Office) which have traversed on State Highway through Delhi Road approximately 3 km and on National Highway through Durgapur Highway approximately 11 km.	The petitioner is absent on call on the time of hearing, so no decision could be taken by the RTA. The Secretary, RTA is directed to call the petitioner again in the next Board meeting to be held on 23.06.2016.

No. 8554 (W) of 2016 of Sabir Ali Mallick have been received	As per Hon'ble Court order dated 26.04.2016, the petitioner was heard and considered. Objection raised from different corner were duly considered and clash free time table was proposed by them.	Considering all objections clash free time table issued vide this office memo no. 1174/MV dated 24.05.2016 will remain in force.
